FINANCE

#### 1.Head Office Dues 2024/25

A very special thank you to all Councils who have paid their Head Office dues. At the end of November there was a sum of approximately £25,000 outstanding from a number of Councils in relation to Head Office dues for the current financial year.

It would be very much appreciated if all those Councils with outstanding dues could pay their dues by the 31st December at the very latest. If there is any reason why your Council is unable to pay, please let Mairi in Head Office know as soon as possible.

#### 2.Head Office Dues 2025/26

At the October Supreme Council in Liverpool, it was agreed to increase the Head Office Dues from £62 to £64 for the financial year 2025/26. The increase of £2 in Dues was in line with the rate of inflation. I realise that some Councils have expressed dissatisfaction with this increase in Dues given the financial pressures some elderly Brothers are facing as a result of not receiving the winter fuel allowance. If your Council has a Brother who is struggling financially there is always the option of applying for a Special Needs Allowance to assist that Brother. Financial hardship should never lead to a Brother having to leave the Order

I am hoping that while I am in the post of Finance Director for the Order Head Office Dues will not increase above the rate of inflation. Sadly, as a result of decline in the number of Brothers in the Order in recent years our income base has declined. Consequently, we will have to look at the way we provide our services to our Members and do things more efficiently.

It is planned to send invoices for the new financial year out in early April with a target date of payment by the 31st July.

#### **3.End of Year Reflections**

As we come to the end of the calendar year, I thought it would be an opportune time to reflect on the finances of the Order. This has been a difficult year for the Order financially and hopefully 2025 will be a better time for all of us.

As an Order we do not always allocate our resources in the best way possible and sadly sometimes we get it wrong. If you have any ideas on how we can improve matters please get in touch at any time.

Therefore, with less income it is imperative that we trim our cloth accordingly. Despite this we have an opportunity to increase our income in various ways to expand our mission.





A number of options springs to mind: a. Sale of Grand National draw tickets

This income remains a major resource to allow us to fund projects for our youth and those in need.

The Order has issued 30,000 tickets to Provinces. If you have received too many tickets from your Provincial Officer, please let him know as soon as possible so that he can reallocate the surplus tickets in good time to other Councils. During the Christmas holiday period and season of good will it is an ideal time to sell your allocation of tickets to your family and Parishioners.

#### b. Making a legacy to the Order

There is always the opportunity of making a legacy to the Order or the Benevolent Fund. In the current year the Order was very fortunate to receive a legacy of just under  $\pm 10,000$  from the family of one our deceased Brothers.

Following the Budget there has been a lot of discussion on the subject of inheritance tax. If you make a legacy to the Order's Central Benevolent Fund (this is where the charitable monies of the Order are held) it will not form part of your taxable inheritance along with any other charitable legacies.

These extra monies, as a result of your generosity will hopefully enable the Order to provide better financial support to Brothers who are struggling financially in any way. If you make a legacy to the Order it will count towards your Inheritance Tax allowance as the Order itself does not have charitable status.

If you would like to know more about the option of making a legacy to the Central Benevolent Fund or the Order, please do not hesitate to email me at any time and I will do my best to assist.

#### I would like to take this opportunity of wishing you and your family the very best wishes for Christmas and hope that 2025 is a good year for you and your family.

## Development

Brothers, firstly I want to thank and introduce the new Development Committee who met on 19th November. Brothers Tony Berkley (Prov 41), Andrew Burns (Prov 10), James Murphy (Prov 9) Charlie Connor (Prov 1), and John Kenyon (Prov 21). We had our first committee Meeting on 19th November and set ourselves some tasks. The next Meeting is planned for 21st January.

The figures at the Supreme Council stood at 2436 Members of the Order. Whilst this meant the Order shrunk by 64 Members over the year, it is the lowest reduction in many years and means **we are very close to growing the order once again.** We brought in 177 new Brothers and lapsation's had dropped from 638 to 173. I am very encouraged by this and also by the start we have made in my first few weeks in the role. See below the recent growth. Let us all ensure it continues.

#### Mission Bulletin for December 2024

#### March for Life UK

Thank you to all Brothers who were able to take part in the March for Life in London on Saturday 7<sup>th</sup> September.

#### The Assisted Suicide Bill

The top priority for us all during November 2024 has been to act on the Bishops' Conference of England and Wales request that all Catholics should contact their MP ahead of the debate in the House of Commons on Friday 29<sup>th</sup> November, to express their concerns about the proposed change in the law, and to encourage their MP not to vote for it. The Bill is euphemistically described by its promoters as being about assisted dying, when in reality the issue for us is that it is a Bill about promoting assisted suicide.

Thank you to all Brothers of the Order who wrote to your MPs - your assistance is very much appreciated. You will know by now that the Bill did in fact receive its second reading at the close of the debate on 29<sup>th</sup> November in the House of Commons, gaining 330 votes in favour, and 275 votes against. The Bill now has to go through Committee and report stages for line by line scrutiny, and then finally to the House of Lords.

Bishop John Sherrington, the Pro-Life, Ethics and Bioethics Lead on the Bishops' Conference of England and Wale, issued a statement after the debate, asking that we pray that our MPs will have the wisdom to reject the Bill at a later stage in its progress, raising specific concerns over the weakness of the conscientious objection clauses in the Bill, and re-affirming that improving the quality and availability of palliative care offers the best pathway to reducing suffering at the end of life. It is anticipated that a Bill with similar objectives will be brought forward in the not-too-distant future in the Scottish Parliament.

#### Advent to Christmastide

We hope that you have all ordered your Keep Christ in Christmas stickers, Christmas posters and Christmas cards. Please issue these as widely as possible. Please also promote the Reverse Advent Calendar and let us all remember those less well off than ourselves in both prayer and practical assistance especially at this time of year.

#### **National Action Project**

The Order's National Action Project from Supreme Council 2022 to Supreme Council 2024 was "Let the Children Live!". Sadly, this did not realise as big an amount for the Charity as had been hoped.

The National Action Project started at Supreme Council 2024 and running to Supreme Council 2026 is Alma Mater, aimed at assisting young women in need at university. More on this in the New Year.

#### **Good Works of the Order**

The surplus raised by our annual Grand National Draw enables the Order to fund projects for Youth and Action. Tickets for our 2025 Draw were issued to Provincial Grand Knights at Supreme Council in October 2024, and we therefore need all Councils to be selling these enthusiastically – **and not just to our own Members**! Please don't be shy about selling these, Brothers. The cash and counterfoils for the Draw need returning to Head Office by Wednesday 19<sup>th</sup> March 2025.

#### <u>Youth</u>

The timetable and specifications for all Youth Competitions from Christmas 2024 to the Summer of 2025 were issued to the Order from Head Office in September, together with some publicity materials for Councils to use. Please ensure that you read the specifications for the competitions carefully and publicise these opportunities for our young people to our Schools, Churches and clubs as widely as possible.

The competitions in the immediate future are:-

- Christmas Photography Competition three age ranges, England and Wales School Years 3, 4, 5 and 6 / Scotland Primary 4, 5, 6 and 7; secondary years England and Wales Years 7, 8 and 9 / Scotland Years S1, S2 and S3; and seniors England and Wales Years 10, 11, 12 and 13 / Scotland S4, S5 and S6. Closing date for the Provinces' **top two** winning entries to reach Head Office is 10<sup>th</sup> January 2025.
- Nativity Scene Painting Competition two age ranges, England and Wales School Years Reception and 1-2 / Scotland Primary 1, 2 and 3; and England and Wales School Years 3, 4, 5 and 6 / Scotland Primary 4, 5, 6 and 7. Closing date for the Provinces' **top three** winning entries to reach Head Office is 7<sup>th</sup> February 2025.

Would Provincial Grand Knights and Youth Officers please set your timetables for the Provincial adjudication of your Council entries received to ensure that the closing dates for your winning entries to reach Head Office are met.



**FLAME 2025** – the next Biennial Flame Congress is in the OVO Arena, Wembley on Saturday 15<sup>th</sup> March 2025. Please support your local Schools and Parishes' needs in helping our young people participate in this event.

#### **Catholic Social Teaching**

We will have regular aspects of Catholic Social Teaching and how it relates to the Corporal Works of Mercy in our Bulletins, for action throughout 2025. As thought-starters, appropriate to this time of year and to the sanctity of life, have you considered:-

- Hot meals during the holidays for school children and their family members?

#### **Inter-Provincial Quiz Competition**

This used to be run by an Inter-Provincial Quiz Committee, but the quiz has not been re-started since COVID. The first and second placed trophies are currently held by Loughborough and Chelmsford Councils, and it would be great to see competition for these trophies once again. We therefore hope to have this competition again at some time during the summer of 2025.

#### **A Challenge for Councils**

Good programmes of activity, at both the National level and local Council levels, are vital to persuading our fellow Parishioners to join us in the Order, and to achieve this we need to widen our horizons so as to take on new initiatives. So, a challenge for you all is to consider when your Council last undertook a new and different activity from your regular work? Could taking on a new activity be your Council's New Year Resolution for 2025?
